

The [International Policy Centre for Inclusive Growth \(IPC-IG\)](#) is a leading global forum for South–South dialogue on innovative development policies, aiming at expanding the knowledge and capacities of developing countries to design, implement and evaluate effective policies to attain inclusive growth.

The Centre is guided by a partnership agreement between the Government of Brazil and the United Nations Development Programme (UNDP). Since its foundation in 2004 the Centre has been providing services and tools to strengthen the institutional capacities of governments of the Global South, including the monitoring and evaluation (M&E) of public policies and social protection. The innovative approaches used by the IPC-IG are based on three pillars: Knowledge Production; Knowledge Sharing; and Capacity Strengthening.

### Projects in 2016

In 2016, the Centre undertook 14 projects in partnership with other institutions, including: the United Kingdom Department for International Development (DFID); The Department of Foreign Affairs and Trade of the Australian Government (DFAT); the German Corporation for International Cooperation (GIZ); the World Bank; the Organization for Economic Co-operation and Development (OECD); the United Nations Children's Fund (UNICEF), the International Fund for Agricultural Development (IFAD); The Food and Agriculture Organization of the United Nations (FAO); the World Food Program (WFP) and its Centre of Excellence against Hunger.

### Facts and figures

Part of the Centre's mission is to produce evidence-based policy research, delivered through several different publication formats, ranging from the popular One Pagers to its flagship magazine, Policy in Focus, to the more technical Working Papers and Policy Research Briefs.

The publications made available online every month, completely for free and in multiple languages, including English, Portuguese, French, Spanish, Chinese, Arabic, Italian, Turkish and Bahasa (Indonesia).

In 2016 alone, the Centre released 145 new publications, which were downloaded a total of 1,234,338 worldwide. Since 2004, the Centre published over 1,408 publications, downloaded a total of 4,911,745 over 180 countries.
